



## Pool Rental Agreement

Members and non-members may rent the Tamarack Pool (Pool) after 6PM on Saturdays and other select dates by special arrangements with the Rental Coordinator.

The rates are established each year and are available on our website [tamarackswimclub.com](http://tamarackswimclub.com). Select the "Rent the Pool" link. Current rental rates are also available at the Pool Front Desk.

Rental includes exclusive use of the Pool facility, grill, and all other pool games and amenities, as well as 3 certified lifeguards, or 2 lifeguards and supervising Pool Board member.

**A \$100 scheduling deposit is required with this agreement in order to reserve your preferred party date.** Parties can be canceled for bad weather with deposits being returned and no penalty incurred. However if the party is canceled for any other reason the deposit will be forfeited to the Pool for loss of rental opportunity. **Payment for the full party rental price is required four days prior to the party.** The pool will not be closed to members until full payment is received. If the Renter and guests are out by the end time and the Pool area is cleaned up, the entire Scheduling Deposit will be returned as soon as administratively possible.

The Renter may have access to the pool one hour prior to the party for decorating at no additional charge, however, the pool will remain open to members during this time. If this set-up timing isn't adequate, additional arrangements can be discussed with the Rental Coordinator to best accommodate your requirements. The Lifeguards will clear the pool 15 minutes before the end of the rental time period to allow swimmers to collect their belongings and be out on time.

Clean up is the responsibility of the Renter and must be completed before the end of the rental period. All trash must be disposed of in the parking lot dumpster. Any overtime (beyond the end of the rental end time) will be deducted from the Scheduling Deposit.
